

When you create a song or any other creative work—whether solo or in collaboration—it's essential to document the contributions of everyone involved. A signed agreement ensures clarity and prevents disputes when it comes to royalty payments or decision-making, especially during licensing negotiations.

It's best to complete this document before your song/instrumental is released, but it can also be completed afterward. Use this template, created by me, Zach Hall, to track the copyright owners, outline who is responsible for any potential copyright infringement, and define who is entitled to royalties. This document serves as a formal record of all contributors and their rights to the work. Keep it on hand whenever you need a clear, legally binding agreement regarding your creative project.
