



# WRITERS SPLIT CONFIRMATION

When you create a song or any other creative work—whether solo or in collaboration—it's essential to document the contributions of everyone involved. **A signed agreement ensures clarity and prevents disputes when it comes to royalty payments or decision-making**, especially during licensing negotiations.

It's best to complete this document before your song/instrumental is released, but it can also be completed afterward. Use this template, created by me, *Zach Hall*, to track the copyright owners, outline who is responsible for any potential copyright infringement, and define who is entitled to royalties. **This document serves as a formal record of all contributors and their rights to the work.** Keep it on hand whenever you need a clear, legally binding agreement regarding your creative project.
